"TOTER" on my property at ANY period of time for which I have been billed to pay.

**Staff Comments**: Under citywide garbage service, all residential properties with up to four units, including rental homes and townhomes, are required to have a garbage cart and receive garbage service for each dwelling unit. Property owners must provide garbage service for all occupied dwellings. There is no option to opt out of the citywide garbage service. This property is registered as a two family dwelling and therefore is required to have two garbage carts on site to recieve garbage hauling services. Resident stated that they have a large 94-gallon containter but that requested that the hauler remove her 35-gallon every other week cart around 07/01/2019. Beacuase the resident requested that the cart be removed, they are being charged for the lowest level of service available. Staff recommends approving the assessment.
