For window with egress opening of 17"H x 24"W - 7 inch variance in egress opening height and no variance needed for glazed area (it's calculated incorrectly)

For window with egress opening of 20"H x 24"W - 4 inch variance in egress opening height and no variance needed for glazed area (it's calculated incorrectly)

For window with egress opening of 20"H x 19"W - 4 inch variance in egress opening height, 1 inch egress opening width and no variance needed for glazed area (it's calculated incorrectly)

WHEREAS, in the matter of the Appeal of Minnesota Rusco, on behalf of Joko Sutrisno and Tri Martodikromo, to three Egress Window Non-Compliance Determinations at 883 PARKVIEW AVENUE; the Legislative Hearing Officer has reviewed the appeal and considered the testimony of City staff and the appellant;
