Ive received multiple neighborhood complaints that the dwelling is being illegally occupied. At the time of my inspection, I found unit-1 to appear vacant but front windows open to entry. Unit-2 had windows open, lights on and classical music playing but no answer at door. There was white Cadillac L#XEC 061 parked in driveway, TGW on boulevard and a discarded wooden book shelf on east side of house. I re-posted vb placards. I also placarded Cadillac for being stored at a registered vacant building. Issuing s/a to secure, cut grass and remove discarded furniture. Ive called PO's and left vm's. Photos attached. ~MD**
