Final Order approving the improvements on the north side of East Sixth Street between Sibley Street and Wacouta Street (File No. S1202). (Public hearing held October 17, 2012; January 2, 2013; and February 6, 2013)

In the matter improving the north side of East Sixth Street between Sibley Street and Wacouta Street by removing the existing 10' sidewalk, abandoning the areaways under the sidewalk as needed, constructing 18' wide concrete sidewalks, completing storm sewer and other related utility relocations, and other related work to complete the project.
