WHEREAS, the Legislative Hearing Officer recommends that the City Council grant the appeal on the revocation by February 22 if the items relating to the gas line and snow and ice issue come into compliance. (Code Enforcement will issue summary abatement on snow/ice); grant until March 6, 2013 for Items 14, 39, 40 and 45; grant until April 1, 2013 for the remaining items; and grant until June 1, 2013 for the exterior painting/scraping; Now, Therefore, Be It
