Authorizing acceptance of HRA-owned parcels in connection with the Heritage Park Project.

WHEREAS, the Housing and Redevelopment Authority of the City of Saint Paul ("HRA") acquired at different times the following properties:

WHEREAS, some of the parcels comprising the Properties were acquired for a proposed housing development that did not go forward because of topography challenges; and

WHEREAS, the City of Saint Paul ("City"), through its Department of Parks and Recreation, has requested that the HRA convey the Properties to the City for the purpose of expanding the land area of the adjacent Heritage Park; and

WHEREAS, on June 12, 2013 the HRA Board approved RES PH 13-138 authorizing conveyance of the Properties to the City; now, therefore be it

RESOLVED, that the Council of the City of Saint Paul hereby accepts the Properties from the HRA for the expansion of Heritage Park; and be it further

RESOLVED, that the proper city officials are authorized and directed to record the deed(s) for said Properties with the Ramsey County Recorder's Office and/or Registrar of Titles and pay all associated closing and recording costs, said amounts to be charged to the proper city account as determined by the Department of Parks and Recreation.
