WHEREAS, the Office of Financial Services Real Estate Section has attached to this Council File both a report of completion outlining the costs and fees associated with Collection of Vacant Building Fees from March 5 to November 21, 2012. (File No. VB1307B, Assessment No. 138818) and the assessment roll including all properties for which these assessments are proposed for Council ratification; and

WHEREAS, the City Council's Legislative Hearing Officer has reviewed an appeal of this assessment and developed a recommendation for the City Council with respect to this assessment; and

WHEREAS, a public hearing having been conducted for the above improvement, and said assessment having been further considered by the Council and having been considered financially satisfactory; Now, Therefore, Be It

RESOLVED, that pursuant to Chapter 14 of the Saint Paul City Charter, said assessment fee is hereby <u>waived</u> <u>until August 1, 2013 to get Fire Certificate of Occupancy re-instated</u>. <u>deleted</u>, provided the boiler is repaired or replaced by October 31, 2013, which shall be reviewed by vacant building staff on November 1, 2013.
