WHEREAS on July 10, 2013, the City Council of the City of Saint Paul adopted File Nos. RLH AR 13-52 and RLH TA 13-325, said Resolutions being the Ratification of Assessment for Property Clean Up Services from March 4 to 27, 2013. (File No. J1309A, Assessment No. 138521); and

WHEREAS, the property at 726 Randolph Avenue, being described as: Scheffers Addtion W 3 Ft Of Lot 6 And Ex W 2 Ft Lot 7 Blk 2, with the property identification number 11-28-23-41-0038 was assessed an amount of \$320.00; and

WHEREAS, the Legislative Hearing Officer recommends ratifying the assessment and payable in one installment:
