Comments: Correction order also issued on July 3, 2013 to remove trash containers from the street/boulevard; replace one container that lacks a lid. On-going complaints of juveniles playing basketball in the street past 11:00 pm; portable hoop that is moved into the street. Sent EC bill \$120 for non-compliance of original orders.
