Comments: The investigating officers on the burglary found the dwelling to be vacant. The inspector inspected

the property on 1/21/14 and found the dwelling vacant and secure. House in poor shape; roof shingles badly deteriorated, chimney leaning, siding cracked/broken, peeling paint/rotting wood frames, deck, stairs, windows, eaves. Inspector opened a Cat 1 vacant building. On 1/22/14, the owner, Roy Carlson, called to say he plans to stay at the residence this summer to fix the roof and make other repairs (with permits). The VB file was then closed by the inspector.
