WHEREAS, the St. Paul Garden Club approached the City of St. Paul's Department of Parks and Recreation to develop a project for revitalization of Rice Park; and

WHEREAS, the St. Paul Garden Club has raised \$46,000.00 and wishes to donate the funds to the Department of Parks and Recreation for development of a conceptual design for Rice Park revitalization; and WHEREAS, it is the desire of the Department of Parks and Recreation to accept the funds and amend the financing and spending budget for Rice Park revitalization; and

WHEREAS, the Mayor, pursuant to Section 10.07.1 of the Charter of the City of Saint Paul, does certify that there are available for appropriation, funds of \$46,000.00 in excess of those estimated in the 2010 Capital Improvement Budget; now, therefore, be it

RESOLVED, that the City Council accepts the donation of \$46,000.00 for the purpose of developing a conceptual design for Rice Park and thanks the St. Paul Garden Club for its generous gift; and, be it FURTHER RESOLVED, by the City Council of the City of Saint Paul, upon recommendation of the Mayor and the advice of the Long Range Capital Improvement Budget Committee, that \$46,000.00 is available for appropriation in the 2010 Capital Improvement Budget, and said 2010 budget, as heretofore adopted by the Council, is here by further amended.
