Inspector Singerhouse and I inspected property and secured back door. This was referred by Sean Westenhofer of Fire, as revoked, however there is no revocation letter in system. House has defective metal eaves, rotted window frames, eletctrical violations as well as a number of items from correction notice. Refuse, carpet, debris in yard, on boulevard and full container. Per Fire inspector's recommendation, open category II VB file, SA.
