WHEREAS, Bad Weather Brewing Company, LLC d/b/a Bad Weather Brewery (License ID #20150000267) applied for a Liquor Outdoor Service Area (Patio) license for the premises located at 414 - 7<sup>th</sup> Street West ; and

WHEREAS, the licensee also applied for a Malt Off Sale (Growler), Malt On Sale (Brewery Taproom) and a Liquor On Sale - Sunday license; and

WHEREAS, the licensee was able to obtain fifty-nine (59) out of eighty-six (86) possible signatures for sixtynine percent (69%) support of the petition required for a Liquor-Outdoor Service Area (Patio) license; and

WHEREAS, the Department of Safety and Inspections received no objections to the issuance of the license; and

WHEREAS, the Council finds that the application is in order and there are no grounds for denial of a Liquor Outdoor Service Area (Patio) license; now, therefore, be it,

RESOLVED, a Liquor Outdoor Service Area (Patio) license is hereby granted to Bad Weather Brewing Company, LLC d/b/a Bad Weather Brewery (License ID #20150000267) for the premises located at 414 - 7<sup>th</sup> Street West in Saint Paul with the following conditions:

- 1. Licensee acknowledges that the licenses issued only permits the sale, service and or consumption of beer which has been brewed by the licensee on these premises.
- 2. No entertainment is allowed on the premises without prior written approval and additional licensing from DSI.
- 3. Licensee acknowledges that the beer service area is limited to the location shown on the approved plan on file the DSI dated 05/06/2015. Any changes to the service area requires prior written approval from DSI.
- 4. There shall be no amplification of music or broadcasted events outside the building.
