WHEREAS, the elections staff completed their annual inspection of polling places and have the following recommendations for the designation of new polling places in preparation for the city and school district election, and

BE IT RESOLVED, Pursuant to Minnesota Statute, Section 204B.16, the Council of the City of Saint Paul hereby approves the following list of polling precinct location changes for the August 11, 2015 School District Primary Election, and November 3, 2015 City and School District General Election.

BE IT ALSO RESOLVED, Pursuant to Minnesota Statute, Section 204B.14, the Council of the City of Saint Paul hereby approves the following list of polling precinct boundary changes for the August 11, 2015 School District Primary Election, and November 3, 2015 City and School District General Election.

Ward 4 Precinct 4 and Ward 4 Precinct 5 be combined into a single precinct to be named Ward 4 Precinct 4 and that the remaining precincts in Ward 4 be renumbered sequentially.

Ward 6 Precinct 2, Ward 6 Precinct 5 and Ward 6 Precinct 6 be combined into two precincts to be named Ward 6 Precinct 5 and Ward 6 Precinct 6, with the dividing line between the resulting two precincts being Forest Street and that the remaining precincts in Ward 6 be renumbered sequentially..

AND BE IT FINALLY RESOLVED, should further changes occur in the polling locations between the date of this resolution and November 3, 2015, the Ramsey County Election Office is hereby authorized to find appropriate locations in which to hold the elections. A postal notification will be sent to all registered voters affected by the changes.
