Yard and driveway full of garbage bags, rubbish, recycling

possession of marijuana and controlled substances. Yard and driveway full of garbage bags, rubbish, recycling materials, wood, auto body parts, etc. Four vehicles illegally parked in yard/inoperable. No marked trash containers on site. Inspector issued orders for: garbage hauler; garbage/rubbish; vehicles; and correction notice. Re-inspection on 3/5/15, there was no change to the property; work orders issued; EC issued. On 3/20/15, owner called inspector indicating they had trash service w/ WM; inspector verified service and contacted Parks to remove container. Re-inspection on 3/24/15, property was cleaned up, PO had trash service, no vehicles were parked in the yard; one vehicle had not been towed; issued \$120 PAEC.

WHEREAS, the Office of Financial Services Real Estate Section has attached to this Council File both a report of completion outlining the costs and fees associated with Excessive Use of Inspections or Abatement services billed February 20 to March 20, 2015.
