**Comments:** Inspector notes: found garbage, wood, dresser, debris in the alley area; tall grass & weeds; two unlicensed vehicles; the cars were so dirty unable to view VIN. Inspector also issued VA. On re-inspection, inspector noted there was no contact from occupants or owner; vehicles now had plate numbers and issued a new VA with compliance date of 8/14/15; garbage/rubbish, tall grass/weeds remained; work orders were sent to Parks.
