Preliminary Order setting the date of City Council public hearing for April 6, 2016 to consider approval of improvements on Randolph Avenue from Syndicate Street to Interstate 35E, and Lexington 300' south and 500' north of Randolph. (File No. 19196, Assessment No. 165206)

In the matter of constructing new bituminous surfaced street with concrete curb and gutter, concrete driveway aprons and outwalks, and boulevards landscaped with sod and trees. The existing lights will be replaced with new lantern style street lighting systems as part of the project. New traffic signals will be constructed at the intersections with Edgcumbe Road and Lexington Avenue. In addition, appropriate storm and sanitary sewer main repairs will be made, lead water services in the right of way will be replaced, and sanitary sewer service repairs will be made at the request of property owners.

Also as part of the project, special attention will be paid to bringing the existing pedestrian ramps up to current ADA standards, with 2 separate ramps in line with the sidewalk in both directions, and with a truncated dome surface. Concrete sidewalks along Randolph will be replaced and widened where necessary.

In addition, Accessible Pedestrian Signals and Pedestrian Ramps will be constructed at the intersections of Randolph Avenue and the I-35E ramps.

This is a Ramsey County project and will be designed by them and they will perform the construction administration. The majority of the project is also funded by Ramsey County.

The Council of the City of Saint Paul, having received the report of the Mayor upon the above improvement and having considered said report, hereby resolves:

- 1. That the said report and the same is hereby approved with no alternatives, and that the estimated cost thereof is \$4,004,818, financed by Ramsey County, St. Paul Regional Water Services, St. Paul Sewer, St. Paul Signals, and assessments.
- 2. That a public hearing be had on said improvement on the 6th day of April, 2016, at 5:30 p.m., in the Council Chambers of the City Hall and Court House Building in the City of Saint Paul.

3. That notice of said public hearing be given to the persons and in the manner provided by the Charter, stating the time and place of hearing, the nature of the improvement and the total cost thereof as estimated.
