The addresses are: 62 Wood St, 64 Wood St, 63 Delos St E, 389 Robert St S, 393 Robert St S, 44 Wood St, 33 Delos St E, 46 Wood St, and 49 Delos St E. 5 of the buildings were no entry on the initial inspection and have an additional 72.00 on their bills, totalling 360.00. These no entry penalty fees cannot be assessed, and reduces the amount sent to assessments from 2691.00 to 2331.00. By not paying the FC of O bills, but adding the assessment fees, there is a savings of 205.00.
