WHEREAS, Ramsey County has committed \$100,000 for the construction of Sepak Takraw (Kato) courts at Duluth and Case and Marydale Parks; and

WHEREAS, the Saint Paul Parks Conservancy is in the process of raising \$100,000 for the construction of Sepak Takraw (Kato) courts at Duluth and Case and Marydale Parks; and

WHEREAS, Parks has realized license fees of \$24,360 that are available for use on this project; and

WHEREAS, said funding has been specifically designated for the Sepak Takraw (Kato) court project; and

WHEREAS, the Department of Parks and Recreation seeks approval to accept this generous funding and express its gratitude to Ramsey County and the Saint Paul Parks Conservancy; and

WHEREAS, it is the desire of the Department of Parks and Recreation to establish a financing and spending budget for the Sepak Takraw court project; and

WHEREAS, the Mayor, pursuant to Section 10.07.1 of the Charter of the City of Saint Paul, does certify that there are available for appropriation funds of \$224,360 in excess of those estimated in the 2017 Capital Improvement Budget; now, therefore, be it
