WHEREAS, the Legislative Hearing Officer recommends that the City Council 1) deny the appeal; and 2) grant to December 1, 2017 to vacate the building an extension to January 2, 2018 to comply with the smoke detectors/carbon monoxide alarms, fire door(s), and door handles; and 3) if those repairs are done, will grant to March 1, 2018 for the remaining items; and grant to July 1, 2018 for the exterior weather type repairs; Now,
