WHEREAS, Ally Hospitality LLC (License ID #20170003905), d/b/a Holman's Table, is applying for Liquor On Sale - 100 seats or less, Liquor On Sale - Sunday, Liquor - Outdoor Service Area (Patio) licenses; and

WHEREAS, per RES 17-1953, the licensee received support from the West Side Community Organization to waive the 45-day notification waiting period and received approval from the City Council for Liquor On Sale - 100 seats or less, Liquor On Sale - Sunday, Liquor - Outdoor Service Area (Patio) licenses, with the following conditions:
