Approving adverse action against the Cigarette/Tobacco license held by Elisea's Snack Shop, LLC d/b/a Elisea's Snack Shop located at 1885 University Avenue West, Ste. 100.

WHEREAS, the Cigarette/Tobacco license held by Elisea's Snack Shop, LLC d/b/a Elisea's Snack Shop (License ID #20110004624) for the premises located at 1885 University Avenue West, Ste. 100 in Saint Paul, was the subject of a Notice of Intent to Suspend License dated January 17, 2018, stating the licensee failed to pay delinquent license and late fees and submit a required Certificate of Compliance Minnesota Workers' Compensation Law form; and

WHEREAS, per Saint Paul Legislative Code §310.05 (m) (2), the licensing office also recommended a \$500.00 matrix penalty for failure to submit required information to maintain the license; and

WHEREAS, the licensee did not respond to the Notice of Intent to Suspend License to pay the delinquent license and late fees and submit the required information, request a public hearing or cancel the license; and

WHEREAS, the Notice of Intent to Suspend License stated that if the licensee failed to pay the delinquent license and late fees and submit the required information, request a public hearing or cancel the license by January 29, 2018, that the matter would be placed on the next available consent agenda to impose the recommended penalty; now, therefore, be it

RESOLVED, the Cigarette/Tobacco license held by Elisea's Snack Shop, LLC d/b/a Elisea's Snack Shop (License ID #20110004624) for the premises located at 1885 University Avenue West, Ste. 100 is hereby suspended.

FURTHER RESOLVED, the licensee is ordered to pay a matrix penalty of \$500.00 for failure to submit required information in order to maintain the license.

FINALLY RESOLVED, the license will remain suspended until all delinquent license and late fees are paid in
