Approving the application of HmongTown Connections Inc. for a sound level variance to present amplified music during the HmongTown Festival on June 23 and 24, 2018 at 217 Como Avenue.

WHEREAS, Chapter 293 of the Saint Paul Legislative Code was enacted to regulate the subject of noise in the City of Saint Paul; and

WHEREAS, §293.09 provides for the granting of variances from the sound level limitations contained in §293.07, upon a finding by the City Council that full compliance with Chapter 293 would constitute an unreasonable hardship on the applicant, other persons or on the community; and

WHEREAS, HmongTown Connections, Inc., represented by Toua Xiong, Owner, who has been designated as the responsible person on the application, has applied for a variance, at a requested sound level limit of 85 dBA at no specified distance, to present amplified music at 217 Como Avenue, Como Avenue between Marion Street and Galtier Street and Thomas Avenue; and

WHEREAS, applicant is seeking a variance for the hours of 8:00 a.m. to 11:00 p.m. on Saturday, June 23 and Sunday, June 24, 2018 during the Hmong Town Festival; and

WHEREAS, if applicant is not granted a variance applicant will not be able to present amplified music at 217 Como Avenue, Como Avenue between Marion Street and Galtier Street and Thomas Avenue; and

WHEREAS, the Department of Safety and Inspections has reviewed the application and has made recommendations regarding conditions for the variance. Now, therefore, be it

RESOLVED, that the Council of the City of Saint Paul hereby grants a variance to HmongTown Connections, Inc. subject to the following conditions:

1) The variance shall be for the hours of 8:00 a.m. to 11:00 p.m. on June 23 and from 8:00 a.m. until 8:00 p.m. on June 24, 2018.

- 2) All electronically powered equipment used in conjunction with the event shall not exceed 85 dBA as measured 50 feet from any stage sound source. All electronically powered equipment, PA systems, loudspeakers or similar devices used in the merchandise areas must not exceed 75 dBA as measured at the nearest residential receiver, and;
- 3) The applicant shall provide personnel and equipment to ensure compliance with the sound level variance conditions.
- 4) All electronically powered equipment, PA systems, loudspeakers or similar devices shall be turned off no later than 11:00 p.m. on June 23 and no later than 8:00 p.m. on June 24, 2018.

FURTHER RESOLVED, that any violations of the conditions set forth above on the first date may result in revocation of the grant of a variance for the subsequent date, in addition to any criminal citation which might issue.

HmongTown Connections, Inc., represented by Toua Xiong, has requested an exemption from the sound level limitations in Chapter 293.07 in order to present amplified music, with limitations, from 8:00 a.m. to 11:00 p.m., on June 23 and 24, 2018 during the HmongTown Festival at 217 Como Avenue, Como Avenue between Marion Street and Galtier Street and Thomas Avenue. Chapter 293.09 provides for the granting of variances from the sound level limitations contained in Chapter 293.07.
