WHEREAS, the Legislative Hearing Officer recommends that the City Council grant 2 weeks for toilet repair, gas line connection to wall repair, smoke/carbon detectors and water heater installation to be permitted and finalised; ~~matter to be referred back to Legislative Hearing on July 31 for a work plan~~ accepts the deadlines outlined in the proposed work plan and grant an extension to September 21, 2018 for compliance with all items; Now, Therefore, Be It
