WHEREAS, the City Council's Legislative Hearing Officer has reviewed an appeal of this assessment and developed a recommendation for the City Council with respect to this assessment; and

WHEREAS, a public hearing having been conducted for the above improvement, and said assessment having been further considered by the Council and having been considered financially satisfactory; Now, Therefore, Be It

RESOLVED, that pursuant to Chapter 14 of the Saint Paul City Charter, said assessment is hereby laid over to March 20, 2019 and if the repairs are done, will reduce from \$2284 to \$1142 and spread payments over 3 years. If the repairs are not done, will approve and spread payments over 5 years ratified and made payable over 5 years.
