Approving a waiver of the 45-day notice requirement to issue Liquor On Sale - 100 seats or less, Liquor On Sale - Sunday, and Entertainment (A) licenses with conditions to Pimento Incorporated, d/b/a Pimento Jamaican Kitchen (License ID #20180004365) at 928 - 7<sup>th</sup> Street West, Suite #104.

WHEREAS, Pimento Incorporated d/b/a Pimento Jamaican Kitchen (License ID #20180004365) applied for a Liquor On Sale 100 seats or less, a Liquor On Sale-Sunday and an Entertainment (A) license for the premises located at 928 - 7<sup>th</sup> Street West, Suite #104; and

WHEREAS, the licensee requested a waiver of the 45-day notification waiting period for approval of the above-mentioned licenses; and

WHEREAS, the Department of Safety and Inspections received a letter from the West 7<sup>th</sup>/Fort Road Federation on December 28, 2018 in support of a waiver of the 45-day notice requirement and approval of the Liquor On Sale 100 seats or less, Liquor On Sale-Sunday and Entertainment (A) licenses; and

WHEREAS, the Department of Safety and Inspections received no objections to the waiver of the 45-day notice requirement and issuance of the licenses; and

WHEREAS, the Council finds that the application is in order and there are no grounds for denial of a waiver of the 45-day notice requirement and approval of the licenses; now, therefore, be it,

RESOLVED, a waiver of the 45-day notice requirement is granted and the Liquor On Sale 100 seats or less, a Liquor On Sale-Sunday and Entertainment (A) licenses are hereby issued to Pimento Incorporated d/b/a Pimento Jamaican Kitchen (License ID #20180004365) for the premises located at 928 - 7<sup>th</sup> Street West, Suite #104 in Saint Paul with the following conditions:

1. All sales, display and/or consumption of alcohol under this license shall remain within the licensed service area, which is the separately defined indoor seating area and kitchen space supporting this use that shall be compact and contiguous with each other, as shown on the approved floorplan submitted with the license application and on file with the Department of Safety and Inspections (DSI).

2. Licensee shall maintain an approved barrier that physically separates and defines the licensed service area to ensure the sale, display and/or consumption of alcohol remains within the approved area.
3. Licensee agrees to close the establishment at 12:00 a.m. midnight each day of the week. All patron/customers shall vacate the premises by 12:30 a.m. each day of the week as per City Zoning Code (parking requirement).
4. Per City of Saint Paul Legislative Code 411.02, the definition of Entertainment A is, "Amplified or nonamplified music and/or singing by performers without limitation as to number, and group singing participated in by patrons of the establishment." (includes karaoke). Entertainment A license does not allow for patron and/or performance dances.
5. No liquor sales and/or service is allowed outdoors without prior written approval and additional licensing from DSI.
