**Staff Comments:** According to information provided by Advanced Disposal, the property owner has only made one payment for garbage service. The property owner paid \$105.68 on 3/19/19 for the Quarter 1 2019 invoice (this amount includes garbage service for 1 64-gallon Medium cart, as well as 2 late fees). The property owner did not make a payment for the Quarter 4 2018 bill.
