Stated Reason for Appeal (if given): Property is currently unoccupied. When the resident does move back in to one of the units he believes does not need garbage service as he brings anything that he would generate to his work.

Staff Comments: The City received notice that one of the units was vacant on 11/16/18. Because the City did not receive notice of a vacancy prior to 11/16/18, the property owner was responsible for paying for garbage service from 10/31/18 - 11/16/18 for one of the units. The delinquent amount of \$147.45 includes service for 1 64-gallon Medium cart and partial service for the other 64-gallon Medium cart from 10/31/18 - 11/16/18.
