Stated Reason for Appeal (if given): I paid the only bill I received from Ken Bergquist,, submitted payment receipt to St Paul on 2/20 to dispute assessment but was assessed anyway.

Staff Comments: The property owner made a payment of \$96.08 to Ken Berquist & Son Disposal on 1/23/19. This payment was processed on 1/30/19. If the property owner made a payment to the garbage hauler after January 5th, 2019, that payment was applied as a credit on their account. The property owner is still responsible for paying the City any outstanding delinquent balance from Quarter 4 2018.
