Stated Reason for Appeal (if given): Zero Waster- Never had service and has never needed it. Has not used the bin since it was delivered in October. It sits unused in his garage. Lot of older people in his alley and many used to share. Frustrated that there is no sharing option.

Staff Comments: Under citywide garbage service, all residential properties with up to four units, including rental homes and townhomes, are required to have a garbage cart and receive garbage service for each dwelling unit. Property owners must provide garbage service for all occupied dwellings. There is no option to opt out of the citywide garbage service. The property owner is responsible for paying the outstanding charge, as garbage service was provided from January through March 2019. The property owner is currently using a 35-gallon Small Every Other Week, which is the least frequent service level available.

WHEREAS, the Office of Financial Services Real Estate Section has attached to this Council File both a report of completion outlining the costs and fees associated with Collection of Delinquent Garbage Bills for services
