WHEREAS, Sister City Delegation visits serve a public purpose of expanding opportunities in the realm of Education, Arts and Culture, Business, and Inter-government Exchange; and

WHEREAS, 2019 marks 31-years of Sister City Friendship with Changsha; and

WHEREAS, Visit Saint Paul has offered to pay for travel expenses (travel, food, accommodations, official gifts) totaling \$3,700 for Council member Dai Thao; and

WHEREAS, the MN Lynx and MN United has offered to donate official team memorbilias as gifts to the Changsha deleagates during the sister city visit totaling \$250; and

NOW, THEREFORE, BE IT RESOLVED, that the City hereby accepts the gift from Visit Saint Paul and appropriates them for the travel expenses of Council member Dai Thao for the official visit to Changsha, China; and

RESOLVED, the City accepts the donated official team memorbilias from the MN Lynx and MN United as gifts to Changsha delegates; and
