Stated Reason for Appeal (if given): The assessment is for service not provided - I am charged for 3 cans & use only 1 can. This is in response to your notice of assessment. This has not been approved by our citizens. Please reconsider this unlawful assessment.

Staff Comments: Property owner attended a legislative hearing on 7/11/19. During the hearing, the legislative hearing officer stated that if the property owner reduced the size of his carts, she would reduce the Quarter 2 2019 pending assessment to reflect the price of the smaller carts. The property owner has not contacted staff stating that he reduced the size of his carts. Staff recommends approval of the assessment.
