Stated Reason for Appeal (if given): Stop putting garbage into my property's assessment

**Staff Comments**: Under citywide garbage service, all residential properties with up to four units, including rental homes and townhomes, are required to have a garbage cart and receive garbage service for each dwelling unit. Property owners must provide garbage service for all occupied dwellings. There is no option to opt out of the citywide garbage service. The property currently has 1 64-gallon Medium cart based off the quarterly amount owed. If the property owner wishes to change to a smaller size, staff can help arrange this with the hauler. The property owner is responsible for paying the outstanding charge, as garbage service was provided from April through June 2019.

WHEREAS, the Office of Financial Services Real Estate Section has attached to this Council File both a report of completion outlining the costs and fees associated with Collection of Delinquent Garbage Bills for services during April to June 2019. (File No. CG1903C1, Assessment No. 190129) and the assessment roll including all properties for which these assessments are proposed for Council ratification; and
