Stated Reason for Appeal (if given): I have had issues setting up the walk up service, and have had the contanner size reduced, plus they have missed picking up the Garbage about half the time. The attached picture is of the smaller contaner which should of been at 47 hatch Ave. this was switched on me in January 2019 and did not get switched back til April of 2019 I have only received Half of the service that I was to be getting.

Staff Comments: Resident reported that that they have been using a small weekly cart as their medium cart was removed. Resident provided proof of small weekly cart as well. Staff recommends reduction in 2nd quarter assessment from \$110.48 to \$70.34.
