**Staff Comments:** AS A PART OF THE SAINT PAUL GARBAGE PROGRAM, ALL RESIDENTIAL DWELLING UNITS ARE REQUIRED TO HAVE GARBAGE SERVICE AND THERE IS NOT AN OPTION TO OPT OUT OF THE PROGRAM. STAFF RECOMENDS APPROVAL OF THE GARBAGE BILL ASSESSMENT.

WHEREAS, the Office of Financial Services Real Estate Section has attached to this Council File both a report of completion outlining the costs and fees associated with Collection of Delinquent Garbage Bills for services during July to September 2019.
