Stated Reason for Appeal (if given): We did not receive any notices of nonpayment at the mailing address requested by the owner. We spoke to customer service representatives at Aspen multiple times to update the mailing address to "P.O Box 211633 Eagan, MN 55121."

Staff Comments: Notices of nonpayment were sent to the mailing address that was request. In addition, payment for the Quarter 3 bill was not submitted until 10/2019, was not able to be processed until after delinquent account was sent to the City of Saint Paul Assessments Office as a pending assessment. Therefore, as the payment of \$25.16 was applied as a credit to the resident's account, staff recommends approving the assessment.
