Stated Reason for Appeal (if given): Deduction for missed pickup in July 2019

**Staff Comments**: Haulers are not required to reimburse residents for a single missed pickup. Resident did not pay \$4.25 of Q3 bill due to a missed pickup, which incurred a late fee of \$4.85 for a small 35 gallon cart. Since the late for for a small 35 gallon cart is \$3.52, staff recommends reducing assessment by \$1.33 for a total of \$7.77.
