Please remove this address from your list of Garbage Non-payment **Staff Comments**: Payment was not submitted until 11/08/2019, and was not able to be processed until after deliquent account was sent to the City of Saint Paul Assessments Office as a pending assessment. Therefore the payment of \$73.86 was applied as a credit to the resident's account. Original notice of nonpayment included was for services provided during Quarter 4 2019. Staff recommends approving the assessment.
