**Stated Reason for Appeal (if given):** Continuation of incorrect billing and services. I would like an accurate assessment of what I already owe. Currently I have two every other week carts but I am being billed incorrectly for two medium size carts. Both small every other week carts were delivered in the month of July. Between January 2019 and July 2019 I only had one medium cart.

**Staff Comments**: Republic confirmed that small carts were deliverd on 09/26/2019 to replace the two medium carts. As the property owner was using the medium size containers for the full service period, staff recommends approving the assessment.
