Stated Reason for Appeal (if given): Resident does not wish to pay for garbage service

Staff Comments: Under citywide garbage service, all residential properties with up to four units, including rental homes and townhomes, are required to have a garbage cart and receive garbage service for each dwelling unit. Property owners must provide garbage service for all occupied dwellings. There is no option to opt out of the citywide garbage service. However, a request was put in on 07/16/2019 to remove the medium

64-gallon cart at the property and replace it with a 32-gallon every other week container. Waste Management has credited \$40.54 to the resident's account, which is the difference between a small 35-gallon every other week cart with three late fees of \$3.04 (\$69.95) and a medium 64-gallon cart with three late fees of \$4.80 (110.48). Therefore, staff recommends approving the assessment.
