**Stated Reason for Appeal (if given):** Resident stated that he was told by city staff back in April 2020 that the city would be paying the Quarter 3 and Quarter 4 bills for residents until the appeal/litigation was straightened out

**Staff Comments**: Staff believes that the resident contacted us during a time when there was a lot of unknowns and there may had been some incorrect information provided.
