Stated Reason for Appeal (if given): Property owner stated that he received notice of a pending Quarter 1 assessment in the amount of \$2.88. The property owner stated that he paid this amount directly to Advanced Disposal. When he received Invoice and Final Notice from the City, he called Advanced Disposal. The customer service representative informed the property owner that they were not able to remove the \$2.88 late fee and that the city must make that decision.

Staff Comments: Hauler requested that the assessed amount of \$2.88 be removed. Therefore, staff recommends removing the assessment.
