**Staff Comments:** Hauler stated that they have not received any payments from the property owner for Quarter 4 2019. They confirmed that they have not sent any employees to the property owners address to collect the payment and that their driver's are not allowed to take payments from the property owners. Staff recommends removing the late fee and reduce the assessment to \$60.83.
