Stated Reason for Appeal (if given): My home was unoccupied beginning Feb 19, 2019 thru Feb 29, 2020. There was no garbage picked up at my home through April 2020.

Staff Comments: Staff was instructed by legislative hearing officer to reduce the assessment by one third. Therefore, staff recommends reducing assessment to \$47.09.
