**Stated Reason for Appeal (if given):** Property owner stated that they currently only have one 64-gallon container at the property that they paid for. Assessment is the remaining invoice for a 35-gallon cart with every week service and additional late fees.

**Staff Comments**: Property originally had a 64-gallon and a 35-gallon cart with every week service at the start of the program. However, the hauler confirmed that the 35-gallon cart with every week service was removed on 07/01/2019. Despite this change, the property was still being charged for a 64 gallon cart and a 35 gallon cart. The total cost of a 35-gallon cart with late fees is \$77.38. Therefore staff recommends removing the assessment of \$75.00. Staff will also request that the hauler provide a credit of \$2.38 to cover the difference between the total cost of the 35-gallon cart (\$77.38) with late fees and the assessment of \$75.00.

WHEREAS, the Office of Financial Services Real Estate Section has attached to this Council File both a report of completion outlining the costs and fees associated with Collection of Delinquent Garbage Bills for services during January to March 2020.
