Authorizing a loan up to \$80,000 from the HRA Business Assistance Fund to Five Star Cafe, LLC, 2469 W. 7<sup>th</sup> Street, District 15, Ward 3

**WHEREAS**, the Housing and Redevelopment Authority of the City of Saint Paul, Minnesota (the "HRA") is a public body corporate and politic established pursuant to the provisions of Minnesota Statutes, Section 469.001, et seq. (the "Act"); and

WHEREAS, the HRA has the power to engage in development or redevelopment activities under Minnesota law and the HRA is authorized to engage in activities relating to (a) housing projects and development, (b) removal and prevention of the spread of conditions of blight or deterioration, (c) bringing substandard buildings and improvements into compliance with public standards, (d) disposition of land for private redevelopment, and (e) improving the tax base and the financial stability of the community, and to engage in the aforementioned activities when these needs cannot be met through reliance solely upon private initiative and which can also be undertaken in targeted neighborhoods; and is authorized to create redevelopment projects as defined in Minnesota Statutes, Section 469.002, Subdivision 14; and

**WHEREAS**, Five Star Café, LLC, a restaurant located at 2469 W. 7th Street, Saint Paul, Minnesota ("Five Star"), requested a loan in the amount of \$80,000 to expand their kitchen, install a hood, and upgrade their dining room to meet the increasing demand for take-out/pick-up orders and grow their business volume (the "Project"); and

**Whereas**, Staff reviewed and evaluated Five Star's request and prepared the Board Report attached to this Resolution, which provides a more detailed summary of the Project and proposed loan terms; and

**WHEREAS**, Staff recommend approval of a loan in the amount of \$80,000 to Five Star from the HRA Business Assistance Fund (the "Loan") consistent with the loan terms articulated in the attached Board Report; and

**WHEREAS**, the HRA Board of Commissioners find that there is a proper public purpose to approve the Loan and allocate HRA Business Assistance funds of \$80,000 for the Project, for the reasons articulated in the Board Report and Public Purpose Summary accompanying this Resolution.

- 2. The HRA Chair or Commissioner, the HRA Executive Director, and the City's Director of the Office of Financial Services are hereby authorized to execute the necessary documents in connection with the Loan, provided that such documents are acceptable in form and substance to the HRA Attorney.
- 3. The HRA Executive Director, Staff, and HRA Attorney are hereby authorized to take all other actions needed to implement this resolution.
