Staff Comments: Staff confirmed with hauler that the only payment made on the account in 2020 was on 8/03/2020 for \$97.72. This was for the Q3 2020 invoice. Therefore staff recommends approving the assessment. It is important to note that the assessment includes the charge for a 64-gal cart from 03/01/2020 - 06/30/2020 (plus late fees) due to service being reinstated at the property during Q1 2020.
