**Stated Reason for Appeal (if given):** After having received as many as five notices regarding an outstanding balance of \$4.97, which we have responded to with full payment, we are now being notified of a Ratification of Assessment. Per the instructions included with the notification, I attempted to make another payment of \$4.97 online but the payment portal/website was not functioning. I do not know if this is a billing system error, if we are consistently being under billed by exactly \$4.97 each month, or if there is some other explanation for this ongoing issue. I do know that this issue is not the result of our delinquency in paying our bills.

**Staff Comments:** Staff confirmed with the hauler that the property owner made a payment for their Quarter 3 on 08/06/2020. As the Quarter 3 2020 invoice was due on 07/25/2020, the payment would be have been received after that deadline and therefore would have received a late fee of 5%, or \$4.97. Staff recommends approving the assessment.
