WHEREAS, Rice Auto Repairs Inc. d/b/a Rice Auto Repairs (License ID #20070004299) applied to add an Auto Body Repair/Painting Shop License to the Auto Repair Garage License it currently holds for the premises located at 601 Rice Street in Saint Paul; and

WHEREAS, the Auto Repair Garage License currently held by Rice Auto Repairs Inc. d/b/a Rice Auto Repairs has a number of conditions which were added by Council after a February 20, 2008 Legislative Hearing on the original application for a Auto Repair Garage License; and

WHEREAS, the same conditions have been added to the Auto Body Repari/Painting Shop License for consistency between the licenses; and

WHEREAS, no petition of support was required for the Auto Body Repair/Painting Shop and Auto Repair Garage license since there are no residential uses within three-hundred fifty (350) feet of the area to be licensed; and

WHEREAS, the Department of Safety and Inspections received no objections to the approval of the license; and
