consistently receiving invoices for garbage from the hauler.

Staff Comments: Staff confirmed that the Quarter 3 2020 invoice and Notices of Nonpayment were sent to the correct property owner and mailing address. The payment for the Quarter 3 2020 invoice was not made until 09/04/2020. Therefore, the hauler was justified in adding two late fees of \$4.65 for a total of \$9.30. Staff recommends approving the assessment.
